# WHAT'S FOGG BEEN UP TO DURING THE LAST YEAR?

It's been one year since we told you what's been happening on the village green.

In March last year we were invited to bid for a pot of money and we scrambled together a project within 4 days. We decided on 2 new resin benches, to revamp the old flower bed alongside Preston Road and to source a Longridge provider of stone on which to fix the QEII plague. All went well with the seats and the plague but unfortunately we underestimated the amount of soil needed to support the G's and my goodness for those of you who haven't bought top soil for awhile it is nearly as expensive as gold! On top of all of this holidays, illness, the weather and holidays caused a delay in the proceedings for which we apologise, but that said we are just a small band of 3 and volunteers to help with projects like this and bulb planting are always welcomed. I am sure when the sedum grows and the small flowers bloom the bed will look very attractive. We aim to plant some crocus bulbs in the bed for next Spring and some clover to attract bees in the summer. The small tree for all you horticulturalists is a crab apple.

Another initiative has been to do some willow weaving with the community payback scheme volunteering to give us a hand on several weekends. They also helped us with the wild flower garden clearing the debris following strimming of the dead flowers in the Autumn. On behalf of FOGG and the residents of Grimsargh I would like to record our thanks for all their hard work.

We put in two further bids to Green Partnership awards and the local members grant to pay for the cutting back the bulrushes in the pond. FOGG paid the remaining costs through their fundraising efforts. More work will be carried out in the Autumn when the water level falls and it fits in with the eco cycle.

The remaining outstanding issue for FOGG is still the drainage of the football field. We met for a site visit with representatives from Preston City Council and they informed us that they have submitted a bid to a city development fund and are optimistic for it's success. And yes we did show them the mole hills!

We hope to continue with our bulb planting and we are currently discussing a bug hotel, so watch out for this welcome development in Grimsargh. Hopefully it will attract more visitors than permanent resident accommodation!

I would like to finish by thanking both Peter and Tony for all their hard work and for those who volunteered or supported us during the last year, and say please more volunteers, whether with fundraising, practical help or other please do contact one us

Memories of the 200 club and the monthly dances at St. Wilfred's club, Longridge, the Father Christmas float (making sure Bert was fully wrapped up with a hot water bottle and flask to keep him warm), field day (the egg and bacon stall and the female adult team v the youth club playing football against each other. Thank goodness for Mr Duff and the late Dr Hodkinson complete with hand bags for joining in with the ladies team), it's a Knock out at the greyhound stadium, yet another rough and tumble, (before health and safety engulfed our lives!) and not to forget our junior grafters who managed to keep silent for one hour. I guess that might be impossibility today.

These are just a few of the memories I have of those years when Grimsargh fostered a great community spirit.

The task was not without it's ups and downs and I am sure you will all have your own memories of floats, field days and walks etc all carried out under the dedication, commitment and watchful eye of Douglas and his wife Helen, without whom the village hall might never have been built.

Douglas not only played a great part in the life of Grimsargh, (he was a Parish Councillor) but he was also a very well respected medical consultant. specialising in cardiology and was in involved in the setting up of the post recovery care of cardiac patients.

We have of course remembered Douglas in naming Douglas Lane after him.

#### **GRIMSARGH WETLANDS**

As most of our residents are aware United Utilities (UU) hosted two drop in sessions last year at the Village Hall to consult on their proposals to hand over to the Parish Council the former reservoirs with a small dowry, in exchange for some limited development on Preston Road. We have renamed the reservoirs Grimsargh Wetlands to reflect the importance of their biological heritage.

Both these sessions were well attended with residents being broadly in favour of the proposals. Some specific concerns had been raised with UU such as the layout of the proposed properties and positioning of the garages and with our help we feel that UU has gone as far as they can to address these issues.

We are still discussing with UU the final details of financing this scheme. As we all know these things do take some time as we need to ensure that we obtain the best possible deal for the Parish Council and residents of Grimsargh. We are currently arranging for local searches to be carried out and we have now received a report from a Reservoir Engineer which outlined all the current information on the reservoirs and the maintenance implications. This will help the Parish Council in negotiating the final costs of this project. In the meantime, we have not been idle and have visited two fairly local

Community owned and managed projects - Garstang Millennium Green and Gorse Hill Nature Reserve in Ormskirk. Although different in size and purpose, there was much to learn that will apply to managing Grimsargh Wetlands in the future, and we are extremely grateful for the volunteers at both venues who have been so generous with their time, knowledge, and advice.

Our newsletter is an ideal opportunity to update you on progress. When UU have finalised their planning application for the proposed development which should be shortly we will of course keep everyone informed







#### **CCTV**

Over the last 18 months, Grimsargh Parish Council has been working with our local police to reduce crime in and around our village and have discussed numerous possibilities.

One incentive discussed -the implementation of CCTV- was identified as being the most beneficial in aiding our local policing team to reduce criminal activity in our community.

With a CCTV system fitted and maintained in the village this will hopefully help the police to apprehend criminals but more importantly will deter them from entering our village in the first place.

At our recent Annual Parish Council Meeting on 14th May, the Parish Council decided to proceed with implementing CCTV with the cooperation of your local policing team to ensure that the village remains a safe environment especially during the summer months.

#### PLANNING UPDATE



Most of you will now know that Preston City Council refused the Gladman Planning application for their development off Preston Road next to Elston Lane. We believe we put together a strong case in opposition to this application – and we were very delighted with the support we received from residents. Particular thanks must go to Jonathan Heaton and Mark Goodwin who provided an exceptional level of support and guidance, for which we are very grateful.

Of course the battle is not yet over, as we know Gladman have submitted an appeal against the decision. At the time of going to press we have not heard of any date for the hearing. We will keep you posted via the website and Facebook (if you've not yet liked our Facebook Page....you really should!).

The Preston Local Plan is the "final" piece in the jigsaw of the update to local planning policy and this is entering what we hope will be the final stages of determination with the completion of the assessment by the Planning Inspector. A key part of the assessment of the Local Plan has been in regard to the five year housing land supply figures – to which the Inspector has made no recommendations for change – which is a strong indication that he deems that Preston City Council can demonstrate that they have an adequate housing land supply at this time. A deficit in this target was a key element of the arguments by Gladman (and other developers) in their cases for their development proposals in Grimsargh. Hopefully the Local Plan will be fully adopted by the end of summer 2015.

#### **LANCASHIRE BEST KEPT VILLAGE 2015**

Last summer we were thrilled to be awarded the Hambleton Shield as runners up to Freckleton in the Large Village category, and it's only natural that we are hoping for that top spot this year!

Independent judging will take place from 6 June until end of July and we receive no notice of the visits, which are quite comprehensive. The focus is very much on how well we 'keep' our village so it's really important that as well as having our planters and floral displays looking their very best we keep on top of litter and weeds. We'll be having at least one mini 'clean up "operation" mid-June so if you'd like to help please follow our Facebook page to find out when and where.



#### JWS RECYCLING PLANT



Some of you will be aware of a recent planning application to increase the hours of working on their licence to 24hrs a day Monday to Friday, and until 10pm at weekends. As your local Parish Council we are aware that there have been concerns raised on noise, smell, light pollution and increased traffic.

Because of this we invited JWS to give a presentation to the Parish Council, and we give a brief summary of this here.

Firstly it is no longer JWS. The building has been bought by a family owned company in the Philippines who are world leaders in plastic recycling. The aim in Preston is to make multimillion pound investment in new state of the art machinery to sort and bale plastic and export it to Asia for processing. To justify this investment they want to operate on a 24 hrs basis and this will create jobs in the area.

To operate 24hrs they are applying for changes to their licence. They want to operate after 10pm, but this will be for working inside the building only.

As they currently have security lights in the yard there will be no increase in light pollution. Traffic Volumes will not vary greatly from present and will only operate within the times of their current licence.

With regards the smell problem they acknowledged that they had had a problem which was actually caused by trying to restrict dust. They have worked with environmental health over this problem, and have now cured it.

From the presentation and response to questions, the Parish Council felt it did not have any reasonable grounds to object to their application to change their licence but we did stress that the licence should be for recycling plastics only at the site. We also suggested to the company that they should smarten up the side of their building so they will hopefully take this on board.

The new company and management are very approachable and are willing to talk to groups or individuals or show them round the factory. If you would like to see the site or have any concerns please contact Damian Perkins, Managing Director on 01772 790893.

#### DISPOSAL OF CONSTRUCTION AND DEMOLITION WASTE AT HOUSEHOLD WASTE RECYCLING CENTRES



We all like taking our rubbish to the tip or to use its correct name the Household Waste Recycling Centre (HWRC), but did you know that from 1 June 2015 residents will have to pay to dispose of construction and demolition waste when taking it to the HWRC!

Lancashire County Council need to make significant savings by 2018 and they have agreed a charging policy to reduce the £750,000 annual cost of dealing with construction and demolition (inert) waste which also includes soil, rubble and plasterboard.

Lancashire County Council is bringing in a permit system which will limit the amount of construction and demolition waste that people can deposit free of charge. If you want to take any of this waste to the HWRC you need to apply for a permit and this will allow you to take to the tip ten 25kg bags of inert waste in a calendar year. Any further inert waste will be charged at £3.50 per 25kg bag. If you do not apply for a permit you will be charged for all your inert waste – this includes items such as a toilet or a sink. This new policy allows each household to deposit free a quarter of a tonne of inert waste each year but we stress that you must apply for a permit. There is no charge for the permit.

Please remember you can apply for a permit at any time but the charging policy starts on 1 June 2015.



## IS DOG FOULING ON THE INCREASE?

A number of people have approached us to complain about increasing levels of dog fouling in the village - pavements, grassed areas and footpaths. And we have noticed it ourselves.

Why you should ALWAYS clear up promptly after your dog:

Dog waste is not only an extremely unpleasant and unwelcome commodity – try cleaning it off the wheels of a scooter at the end of the school run - but is also the perfect breeding ground for bacteria (Campylobacter and Salmonella) and other forms of infection.

The most damaging of these is caused by the roundworm Toxocara canis. The eggs of this parasite are present in much dog waste and although initially not infectious, once the eggs hatch they pose serious health risks to any individual unlucky enough to ingest infected soil.

The effects of Toxocariasis range from mild flu like symptoms that often go undiagnosed to a more worrying form that affects the eye and can lead to permanent blindness.

So those are the risks for the "victims" of dog fouling. The risk for the guilty party is a £50 fixed penalty notice, with the possibility of a court case and up to £1,000 fine. Why risk it when there are bins well placed throughout the village?

Most dog owners are responsible and do clear up after their dog. Sometimes one may genuinely not have spotted when the dog has "been" – many people will feel confident enough to help them out there and point it out.....some may not.

So....please ensure that you always clear up immediately after your dog. There is no excuse for not doing so. Help us to identify any culprits who are failing to be good neighbour and who are also breaking the law.

If you are aware that someone is persistently offending, then the responsible thing to do is to report them – firstly to Preston City Council, and if they are unable to do anything, to the police (contact details given below).

## To those dog owners who are less careful, the message is simple:

It's your (dog's) mess - clear it up!!
