# The Story So Far...

JWS Waste & Recycling began discussions with Valpak regarding the Grimsargh site back in September 2012 and by working closely with key local waste producers, a business plan was developed which catered for waste which could not otherwise be recycled or reused and was destined for landfill.

The existing business under Valpak was struggling under difficult economic conditions and was not profitable, however what was quickly identified was the dedication and commitment of the staff to make it work. Continued overleaf

#### **Baling & Wrapping**

Loose material is sorted, baled & wrapped onsite ready for onward transportation to Norway & Sweden to offer heat & power to community homes

### **Dry Mixed Recycling**

JWS Lancashire organises the collection, aggregation and sale of dry mixed recycling, including cardboard & plastic from local businesses.



### What We Do

JWS Lancashire are a local company based in Grimsargh employing 20 people & provide waste management services in and around Lancashire.

The services we offer aim to divert difficult to recycle waste away from landfill, providing a positive outlet in the provision of energy to homes across Sweden & Norway.

Working with key partners such as Lancashire County Council & Global Renewables, JWS Lancashire form part of an overall waste strategy aimed at reducing, reusing and recycling wherever possible.




# The Story So Far...

Continued...the takeover of the site and operations was completed in February 2013 and from that point JWS Lancashire committed itself to an extensive program of change and improvement.

This development of the JWS Lancashire business has not been easy on many fronts, fundamental changes to the operations, policies & procedures have all required a significant investment in both finance & expertise. Combined with continued commitment to environmental compliance of the site and its permits with the Environment Agency and our endeavours to be a good neighbour, it's fair to say this has a been a challenging year.

Each change we have implemented is to try and give JWS Lancashire a sustainable and secure future. This has had a knock on effect and these challenges are ongoing. This has resulted in an increase in the number of complaints received regarding the JWS Lancashire site, peaking in November 2013.

We acknowledge that the impact of litter and odour on our neighbours has caused upset and we are working tirelessly with the Environment Agency to try and resolve this for all parties. This continued attention to the complaints received and the resulting changes and improvements have seen the number of complaints fall by over 90%

We have also noticed that a number of the complaints received were described as a 'sweet smell' which we believe may have been an odour dilutant, not the actual waste. As a result we have now changed the dilutant to a 'neutraliser' which appears to be having a positive effect.

Further improvements are detailed on the following page but one of the major changes has been to bring the loose material into our Materials Recycling Facility and process it inside, therefore reducing the likelihood of odour significantly.

We must stress that this is an ongoing program of improvement, and we still have much to do, but we remain committed to getting the business on a firm sustainable footing, employing local people, and being a good member of our community.

We can only do this by listening to our neighbours and acting upon the feedback we receive in a meaningful way. JWS Lancashire operate an open door policy and we welcome visitors to site within operating hours, both to discuss any issues you may have with the site or to take a tour of the facility to get a better understanding of what we do and how we do it.

We are endeavouring to get to a stage where we can be considered good neighbours and we hope we can get the opportunity to demonstrate this to you on a consistent basis.



# Improvements Made At JWS Lancashire

Working in the waste industry can mean working with materials that could be considered unpleasant or undesirable and so the balance between providing an efficient waste solution and being a good neighbour sometimes can be a difficult line to tread.

Since taking over the site in February 2013, JWS Lancashire have worked hard to reduce the impact of its operations on the community. We work in close partnership with the Environment Agency & have implemented a comprehensive improvement strategy to minimize any negative effects on our neighbours.

Following feedback received through the complaints process some of the key improvements have included:

- Bringing all the loose waste material within the building, instead of processing outside, this has reduced noise pollution and odour significantly.
- Reducing the amount of tonnage we take onsite in order to process and turnaround quickly
- Baling & wrapping of the loose waste within the main building reduces odour & eliminates potential for littering.
- Odour suppressions systems have been installed and following feedback continually assessed and improved

These improvements are ongoing & JWS Lancashire encourage staff to make suggestions, rewarding their ingenuity with prizes & recognition
